## **TERMS & CONDITIONS FOR STALLHOLDERS 2011**

**The Fleurieu Folk Festival** is an event attracting a wide audience for a weekend of music, poetry, dance, performance, workshops, and family entertainment.

We aim to attract stalls that will provide Festival patrons with an enticing selection of craft and merchandise, and good food.

We favour towards an all Australian handcrafted and homemade specialist goods.

Stalls that are bright and festive with a clean appearance and of interest.

You are required to decorate your stall in a manner that reflects your goods and to attract patrons.

Quality of stock is to be acceptable and have new and innovative ideas.

You should show professionalism and experience.

You may operate your stall from:

**06pm – 12midnight on Friday 21st October**  
**10am – 12 midnight on Saturday 22nd October**  
**10am – 08pm on Sunday 23rd October**

The stall fee is **\$100.00** for the **weekend** (eg 4pm Friday – 9pm Sunday).

If you require **electricity** this will be an extra **\$5** per outlet.

- **Stallholders are asked to submit an application form detailing their proposed stall, product or service and power requirements with, if possible, photos of your stall, by the 31<sup>st</sup> August 2011. Payment in full must be sent with the application to Fleurieu Folk Festival, PO Box 52 Seaford SA 5169. Cheques should be made payable to Fleurieu Folk Festival Inc.**
- **Public Liability Insurance is compulsory covering all stallholders and workers. A copy of your current Australia Wide Public Liability policy must be forwarded to the Committee with your application.**
- **If you are employing people to work on your stall, you must have Work Cover policy. A copy of your Work Cover policy must be forwarded to the Committee.**
- **Stallholders who are selling food must adhere to the South Australian Health Department Food Act 2001 and have a current Food Registration Number issued by their local council.**

## **REFUND POLICY**

Stallholders will receive a refund of half of the Stallholder fee should a replacement be found for that space. Should a replacement not be found, the Stallholder will forfeit the full Stallholder fee.

## **DAMAGES**

Any and all damages caused to the venue, whether intentional or unintentional inflicted by the Stallholder or staff, shall be passed on to the Stallholder.

The Stallholder will be billed accordingly.

## **ALLOCATION OF SPACE OR SITE**

Stallholders requesting special areas or needs should specify this on their application. The Festival Stalls Coordinator shall assign a site and will have the final say on where stalls are located.

Stallholders shall not extend beyond their boundaries of the nominated site with displays etc.

**NO** sharing, sub-letting or assigning all or part of your site to another stallholder.

## **SIGNAGE**

Stallholders **may** display or attach their own signage, but it must be strictly within their allocated space and attached to their own property.

You are not limited to decorations but signs and banners **may not** be taped, nailed, glued, screwed, tacked, stapled, or otherwise fastened to ceilings, walls, painted surfaces or columns in the venue.

The venue prohibits the use of all tapes on their walls and floors and on painted or portable walls.

No holes may be drilled, cored or punched in the venue.

No sand, confetti or other miscellaneous decorations are allowed in the venue.

## **INFORMATION & PRODUCT STALLS**

Stallholders are charged the same as for Craft & Merchandise and the same conditions apply.

## **STALL CONSTRUCTION**

Camping tents are not considered suitable for use as a stall.

## **CAMPING**

Behind your stall only, where possible, the width of it and to a depth of 3 metres and not for trading purposes. We **DO NOT** guarantee camping behind your stall.

## **VEHICLE**

You may park one vehicle behind your stall where possible, providing it does not move during the festival. Vehicles **must not** be parked in the main festival arena.

## **WET WEATHER**

Some years we experience rainy/windy days and unprepared stallholders have a hard time.

You must ensure that you have decent flooring and a wet weather plan for your stock.

**Damage to your stock is your responsibility.**

## **RISKS**

Stallholders are responsible for their own property, merchandise and money.

Please take precautions against placement of your merchandise and cash to guard against the possibility of theft or loss from any cause.

## **FOOD**

Stallholders selling food must have knowledge and adhere to the South Australian Health Department Food Act 2001. **Any contamination to patrons is your responsibility.**

## **POWER**

The Festival is limited in the amount of power we are able to supply to stallholders. If you require power to your stall you must indicate this on your application. Please provide details of any appliances and power usage, i.e. number of outlets and amps. There is an extra charge of \$5 per outlet for supply of electricity.

## **SAFETY**

All fire, safety and building regulations must be strictly adhered to and followed according to the law. Particular attention should be adhered to prohibitions of toxic chemicals. All electrical equipment including power leads must be checked and tagged by a qualified electrician. **The Festival will not supply power to stalls that do not meet these requirements.**

## **SOUND**

Use of amplifiers or loud speakers is not permitted.  
Cassette players are allowed with Committee approval. Music is to be in the Folk Genre.

## **BEHAVIOUR**

Stallholders showing any signs of abusive, drugged, drunken or offensive behaviour will not be tolerated and the offenders will be evicted.

## **PETS/ANIMALS**

No pets or livestock will be permitted on and in stalls.  
Stallholders are NOT to sell animals.

## **NOT FOR SALE**

### **ADULT MATERIALS**

**No public showing or sale of adult merchandise animated or live film which is sexual or pornographic. Stallholders found with these items will be reported to the authorities and evicted.**

### **OFFENSIVE GOODS**

**Plastic phallic toys etc, illegal and offensive products. Stallholders found with these items will be reported to the authorities and evicted.**

### **WEAPONS**

**NO weapons of any kind eg guns, knives, knuckle dusters etc. Stallholders found with these items will be reported to the authorities and evicted. Toy weapons are not allowed.**

### **BOOTLEG/PIRATE COPIES**

**NO bootleg merchandise is to be sold eg CD's, DVD's, LD's, and Videos.  
Selling legitimate products sealed in plastic wrappers are allowed.**

**Fleurieu Folk Festival Committee** retains the right to enter the site of any exhibitor at any time and remove any item, article, product, sign, picture or printed matter which in our opinion is offensive.
